## Charter Goals for 2018-2019

Kathy Butler updated us on the financial part of the charter

Four goals were proposed:

- To increase attendance at Leader's Association meetings by 10% by July 2019. (not used)
- To create and distribute a flyer/pamphlet about what 4H has to offer and distribute it to libraries, schools, community welcome wagons, restaurants and real estate offices by July 2019. These would be offered in both English and Spanish.
- To have board members attend club meetings other than the club they represent to gain input on programs and ideas and education the general membership what the leaders association does. All clubs would be visited at least once by a non-member board member during the 2018-2019 4H year.
- To celebrate and share the great accomplishments our clubs do by including a shout out/sharing agenda item on each Leaders Association agenda starting with the November 2018 meeting.

Bench/Planter - Diane Hamm reached out to Lynn Neumann and is working on moving the hen house and planter benches to Diane's house.

Dan Paulus moved that once items are moved, post to Facebook Marketplace for 30 days for prior set prices of which if no buyers for set price take best offer. Diane Hamm second. Unanimously approved.

Construction Trades Shed - Debbie Poull will contact places to move shed to fairgrounds at cost to project.

Meat Sale Profit Distribution - Amount of club sales was presented by Kathy Butler. Discussion on what to do with leftover meat with ideas....give meat to clubs to decide, donate to raffle or food pantry...it will be brought to next Leaders Association meeting for input and offered to clubs first and go from there.

T-Shirt Funding - income from adult shirts will offset cost of t-shirts being over budget and net cost will come in under budget. Note for next time to budget both income and expense and/or budget more for cost.

Jumping Country - update from Roger Knepprath as to available dates, Jan. 4/5 or 18/19. This event was not budgeted for but found to be a well-attended event and gives youth a one night away from home experience before taking on camp. Because of rising costs, other venues need to be looked at for upcoming years. Debbie Poull made motion to approve \$1550 net loss for Jumping Country cost. Josh Riemer second. Unanimously approved.

Dan Paulus moved to adjourn the meeting, Amir Spangler second. Unanimously approved.
