- Insurance billing Jayna will look into getting billed quarterly to avoid frequent requests for payments that are very small amounts.
- The board will look into creating an event chairperson handbook. This could be a possible charter goal for 2020-2021. Jayna will check to see if other county programs have something we could use as a model.
