### **Guest Speaker - John de Montmollin on shooting sports charter**

Some background - 2017 State 4-H program went under Civil Rights review.

Outcome was to be looking at structure in 4-H program - used only one model in the past (100% use of multi-project community clubs) As a state organization, we need to consider all other structures (multi project community club, after school club offered in after school clubs or partnered with someone else) An after school site can restrain membership age, in school club partnership with the school and can be down to a certain grade, military club specifically designed to be on a military base - this constrains membership to families on the base. We also considered multi-project and single project community clubs (this is done a lot out west). You can be in more than one club at one time.

- Q: If youth is in more than one club, will they be able to have time for requirements of both clubs?
- A: Regardless if it is a project or club, there are demands. It could take away from community club but we may need to look into making sure overall that requirements are things that are opportunities and not burdens. It does depend on what the bylaws and the board distinguishes on what requirements are.
  - Q: Can members join the Shooting Sports as a project member only yet?
- A: Depends on how it is set up. They just need to make sure that the club meets the requirements to be a chartered club.
- Q: Does this mean that any of the county wide projects can redo their charters as a club and not a project?
- A: Yes, if they recharter and meet the requirements Biggest difference in community clubs is that leaders are appointed by the office but in projects the leaders are voted on by the membership.
- Q: Was the InStride club a single project club? A: not really but may had been the intention was to be a single project club
  - Q: How will ownership of equipment be decided since the Leader's Association paid for them?

- A: Needs to be discussed and decided on by the Leaders Association. Maybe an MOU?
- Q: How are members to deal with fundraisers, service hours, scholarships, trips, etc?
- A: The club must meet the state requirements to be a club, all opportunities are open to all members. Scholarships are awarded and need to be addressed in those processes.

Bottom line: The state sets basic standards that meet the 4-H requirements to become a club and then individually clubs can set other requirements. It's important to hold kids accountable but make sure they have access to the program. Is this 4-H group about Mastery: Generosity: Independence: and Belonging: We need to make sure that is the focus of all clubs.
