Old Business

- Insurance Policies Update
 - Clarifying email from UW Madison (John M.), stating that lots of events are covered by UW system, but it was clarified that the leaders are what is covered if they are working at an event
 - The Haunt will be covered through Statewide

- Policy is in place, we just don't have a physical copy as it continues to be getting updated
- Putting events on the policy that would have the most liability
- Insurance Information from John de Montmollin (State Extension):
 - Liability coverage (if we were to get sued) is for volunteer leaders and is covered from the state without us paying anything (all LA members) and clubs and groups (any organization) are not covered
 - Questioning if 4-H and Extension Policy for the Annual Accident for Insurance Group Application from has been purchased for a \$1 per member/\$2 per horse member (Ohio based company, specific to 4-H-American Income Life), accident Insurance (approximately \$5,000 before any health/dental/accidental death insurance would be paid)
 - The \$0.35 a day policy has more coverage (ex. Illnesses, etc.) and is recommended for anything overnight where youth are away from their parents
- Tracy from West Bend Mutual is stating that \$75 is still owed, needing a break down of itemized payments, Jess is going to reach out and investigate further
- Erin Puro motioned that the \$1 per youth member/\$2 per horse member would be covered by the Leaders Association, as well as the \$0.35 a day policy when needed up until the next fiscal budget, Deanna Lee seconded, unanimously approved
- Current enrollment as of 2/15/24: 172 (approved) volunteers, 450 total cloverbud and youth members (of the above numbers: 42 are youth horse members, 15 adult leaders)
- Bank switch update
 - Account has been signed (President and Treasurer have access)
 - Treasurer in training
 - Deanna Lee motioned to allow the onboard process to begin to train Jess Vento to have Quick Book and account access, Erin Puro 2nd, unanimously approved
- Google business update
 - Email domain has been created
 - Still working with Google regarding the nonprofit account, due to us not having our own website
- AED update
 - Pictures have been taken and information has been sent to the rep
 - Various quote packages available if we would be interested
 - Dan Cehanovich motioned to move the AED to the storage facility, Lori Hosseini, unanimously approved

 - Fast Fun February opportunity what was 5% up to 10% and 15% up to 20%
 - Need a more efficient system for this fundraiser
 - Deanna Lee motioned to purchase \$2,000 worth of Kwik Trip cards during this
 promotional period (70% gas and grocery all cards will be worth \$25, 30% car
 wash car wash cards will be worth \$40), with the funding of 5% and 15% still
 going directly to the clubs and the remaining funds going back to the LA, Lori
 Hosseini seconded, unanimously approved
- Lending walkies to Fish Days
 - Sue Dowe is on the committee and they are looking to borrow the radios for a day to determine whether they would like to purchase them for their event
 - We are not interested in borrowing out the radios, we can share the link for the specific radios we purchased if they are interested
- Project Bunny
 - March 16th, 2024, 10:00am-12:00pm
 - Poster will be getting shared with school and social media
- Volleyball Tournament
 - Lisa Spangler is in charge of this event and scheduled it at Port Washington High School for Saturday April 27th
