 - Tammy Schuster motioned that we fund the Day Camp from June 26th-29th with one overnight opportunity, Danielle Gettelman 2nd, unanimously approved

 - Jess Vento motioned to approve the additional cost of \$1,818.25 to cover the insurance policy for the Haunt, Tammy Schuster 2nd, unanimously approved
 - Russell will be asked to come to our November meeting
- LA Items in the Extension office still working on it
 - Hwy 60 storage unit also needs to be sorted through to ensure we are using the space appropriately
- Policy/Forms Update Complete and vote worked on Friends of 4-H, Leader recognition and new member forms
- Storage Facility code policy of who has code, when to change, inventory
 - Not changing it anyone in charge of event that needs access can have code until a problem arises

Board Goals

- The Leaders Association will provide any club or project leader who is interested in guidance on our consistent accessible platform through two workshops held during the 4-H year of 2024-2025.
- To spark interest in 4-H, our members will develop a marketing resource that highlights member learning, service activities, and how to join 4-H by August 2025. The advertisement/commercial/pamphlet will be distributed/ displayed at locations, like The Rivoli, Ozaukee Family Services, Family Sharing, Ozaukee Food Alliance, Habitat for Humanity, and Family Promise of Ozaukee, etc., which serve community members not generally familiar with 4-H, by August of 2025.
 - Lori Hosseinimotioned to approve the new board goals as stated above, Sue Dowe 2nd, unanimously approved

New Business:

- Glander Cake Decorating award
 - Jess Vento motioned that we would purchase a second award for this year due to the confusion with it be given to two youth, Tammy Schuster 2nd, unanimously approved
 - Lori Hosseini will be adding this award to the Business Awards for future fairs to eliminate confusion and keep it consistent
- Lending LA items out to 4-H members for non 4-H events
 - Conversation to be brought to the whole LA group to determine thoughts for moving forward with this
- Nominations awards and outgoing members
 - Currently 2 adult applications
 - Currently 5 youth applications
 - Tammy Schuster motioned that if you are a current youth member and apply for a second consecutive year on the board you will automatically be accepted for that position, Danielle Gettelman 2nd, unanimously approved
 - Vote to the LA members will go out to determine the selection of the other two vacant positions
- National Competition Travel for Horse Education Team
 - Looking for the LA to sponsor according to the policy
 - Tammy Schuster motioned to support the current LA policy, Lindsey K. 2nd, unanimously approved
 - National Contest Funding Policy:
 - The purpose of this policy is to help fund and recognize teams and individuals representing Ozaukee County 4-H at 4-H Sanctioned National competitions. 4-H members that qualify for a national event have spent numerous number of hours preparing and competing to get to the National level. They are proudly representing Ozaukee County 4-H at a National level and the Leader's Association recognizes the hard work.
 - To qualify for this funding a team/individual must:

- Must be a current member of Ozaukee County 4-H in good standing with their club and the project that they are qualifying through
- Present the following information to the Leader's Association Board within 4 months of completing the National event:
 - The process they went through in training and qualifying for the national competition
 - Information as to where, when, and what competitions that they competed in
 - How have they grown in the process
- Each team/individual that completes the previously stated will be awarded the following monies:
 - 25% of miles of round trip to destination multiplied by the current UW system mileage reimbursement amount
 - \$75 dollars for each day they are competing to be used at their discretion
- Trip Scholarship resume and interview workshops
 - Applications are due by the end of October
 - Interviews will be scheduled for early November
- Open House
 - Thanks for all the help, everything went very well
 - Almost double the attendance this year: North: 21 adults and 26 kids, South: 31 adults and 36 kids
- Clinics sponsored by Foundation
 - Clinics to help with projects without leaders or want extra help learning skills
 - Leaders need to schedule but Foundation will provide financial support
- Looking at possibly hosting future LA meetings at PWSB community building space
- Any other business?
