# 4-H Program Educator Update - Abi Quinlin

-Bylaws: Worked to update the document to meet the State requirements -Funds: At the March meeting, I mentioned that the state committee was reviewing the policy regarding the amount of funds clubs and groups are permitted to maintain their nonprofit status and 4-H association. They have decided not to amend the existing policy; however, the Ozaukee 4-H Leaders Association is still not within that policy - by a substantial amount. LA will need to spend roughly \$145,000 in the next 5 years to maintain our nonprofit status. Telegram will be getting implemented to help spread information throughout the county and that will help to promote trips/scholarship opportunities coming up. Possible larger expenses coming up: flagpole project, storage facility needs, RC needing relocation for track to be put and stored at, travel trailer interest -Ozaukee County 4-H Programming Standards: Through recent assessments and conversations, it became clear that consolidating our various policies, codes of conduct, and operational guidelines into a single, accessible document would greatly benefit our community. With state support, I've developed the Ozaukee County 4-H Program Development Standards to serve as a comprehensive reference for planning and executing club and group activities. This resource aims to provide clarity and consistency, ensuring our programs continue to reflect our shared commitment to positive youth development.

-Fairgrounds MOU: The Fairgrounds MOU is scheduled for a County Committee vote on April 17, 2025. Amanda Clausing shared with the county the details from the Horse and Pony earlier this week, and I will pass along any new information as soon as possible.
